It is particularly urged, that hereafter the clerks of churches furnish tables in the order and form in which they are printed in the Minutes of this year; and to enclose all moneys in exparate letters to the Clerk or Treasurer of the Association—by observing which much time and labor will be saved.

THE CONSTITUTION

OF THE

HUDSON RIVER BAPTIST ASSOCIATION.

ADOPTED Nov. 21, 1815, AND AS SUBSEQUENTLY AMENDED.

ART. 1. This Association shall be known by the name of "The Hudson River Baptist Association," and shall be composed of ministers and delegates only, who are members of the churches they represent, excepting such as may be invited to a seat by the consent of the body.

ART. 2. This Association shall meet annually, on the Tuesday Before the third Wednesday in June, at the place previously appointed.

ART. 3. After Public Worship, the Association shall proceed to choose by ballot, a Moderator, Treasurer, and Clerk. No person shall be eligible to an election as Moderator two years in succession.

It shall be the duty of the Moderator to preside and lead in all the transactions of the meeting, and to see that order and decorum are observed by all the members.

The Treasurer shall receive all moneys belonging to the Association; keep an accurate account of the same, and the objects for which they are designated; pay them out according to the order of the Association; and make a report of the state of the treasury before the close of each session.

It shall be the duty of the Clerk to keep a fair and impartial record of all the business transacted during the session.

These Officers shall continue in office until succeeded by new appointments.

ART. 4. At the first meeting of this Association, a Secretary shall be chosen, to continue in office at the pleasure of the Association, whose duty it shall be to take charge of all the records, and to correspond with such societies, churches, or individuals as the Association shall direct.

ART. 5. It is expected that the churches will send, with their messengers and letters to the Association, an account of the state of their respective churches; particularly of the additions and diminutions in the past

year, and generally of whatever relates to their peace and prosperity, together with the whole number of members in communion. With these letters each church shall forward money for the printing of the minutes.

ART. 6. Churches who wish to be received into this Union, may apply by letter and messengers; and giving satisfactory information of their being sound in doctrine, and correct in practice, they may be received; and as a token of the same, the Moderator, in behalf of the Association, shall give them the right hand of fellowship.

ART. 7. This Association has no power as a legislative body. It is merely a fraternal conference, to learn each others state, to cherish brotherly sympathy and union, and to advance each other in the faith, love, and hopes of the gospel, by united prayer for the Spirit. and by free conference. Remembering the past history of the church, and the fatal usurpations of synods, those earlier associations, although constituted upon republican models, by delegates of independent churches, yet building up ultimately spiritual despotism, this Association would, with the strictest jealousy guard against similar assumptions. It disclaims, therefore, all power of making law, under any pretext, for the churches.

ART. 8. Although as an associated body we utterly disclaim all power over the churches, so far as it respects an interference with their independency and discipline; yet we deem it our privilege to judge for ourselves of the propriety of continuing any church in our connexion. In order, however, that we may not withdraw our fellowship without sufficient reason, it is proposed, that when a complaint is made by any two churches of this body against a church belonging to this Association, (if thought expedient,) the Association shall appoint a Committee, who shall request a conference with said church, in order to obtain satisfaction on the points which formed the subject of complaint, and the result shall be reported to the next meeting of the Association, in order that they may decide as duty may require.

ART. 9. When a church shall neglect making any communication to the Association for the space of three years together, it shall be considered as having withdrawn from us, and of course shall be dropped from the Minutes, unless two or more members shall request their continuance, and will also engage to inquire into their standing, and report at the next meeting of the Association.

ART. 10. The Association shall have a right to open and hold correspondence with other Associations as it may think proper.

ART. 11. It shall be the duty of the Association, from time to time, to suggest to the churches what they may think most expedient to be done to promote the spreading of the gospel in the world.

ART. 12 This Association when convened, shall appoint the time and place of their next annual meeting; select a person or persons to preach on the occasion, and shall from time to time, make such amendments and alterations to this Constitution as experience may dictate.

RULES OF ORDER.

I. At every sitting, business shall be opened and concluded with prayer by the Moderator, or whomsoever he may request.

II. Ministers present, invited to a seat with us, may debate on all sub-

jects, but vote on none.

III. No member of the Association shall absent himself without leave of the Moderator.

IV. No subject shall be discussed, without a motion first made and

seconded.

V. No person shall speak oftener than twice on any motion, unless by permission of the Moderator.

VI. Motions made and lost, shall not be recerded on the Minutes, ex-

cept so ordered at the time.

VII. If, when a motion has been made and seconded, a member opposes its being discussed, the Moderater shall immediately put the question "Shall this question be discussed?" which if negatived, the subject shall be dismissed.

VIII. If any proposition or motion under debate contain two or more points, it shall be divided at the request of any member, and the vote

taken separately.

IX. Arrangements for the next Association shall not be attended to on

the first day of the session.

- X. On the opening of business the second day, the roll of the messengers commissioned by the churches shall be called, and the names of those who have not arrived shall be stricken off. Nevertheless, ministers and licentiates shall be inserted with the mark of absence.
- XI. Delegates sent to this Association will remain until all the business is finished; if not, their names shall not be recorded, unless they have been excused by the Moderator.
- XII. The minutes shall be leisurely read and corrected before the rising of the Association.
- XIII. In distributing the Minutes at the close of the Association, only one member from each church shall come forward. If a surplus remains after these are supplied, they may be taken indiscriminately.
- XIV. Immediately after the Association has met, the Moderator of the last session, or in his absence the Chairman who presides at the organization of the Association, shall forthwith, after taking the chair, appoint a Committee to report upon the state of religion, and the members of such Committee whilst engaged in preparing their report, shall be excused from their attendence upon the Association.
- XV. These rules shall be distinctly read from the Chair immediately after the organization of the Association.

MINUTES.

TUESDAY, JUNE 15, 1847.

At 10 o'clock, A. M., the Association assembled in the meeting-house of the Twelfth-st. Baptist church, in the city of New York. Introductory prayer by brother J. H. Walden, of Troy.

1. The sermon was preached by Rev. Henry Davis, of New York, from 2 Timothy, 2d chapter, 10th verse.

Concluding prayer by brother Rodgers of New Jersey.

After which a collection for the Widows' Fund was taken, amounting to \$20 72.

2. The Chair was then taken by Rev. J. L. Hodge, the Moderator of last year, and the Association proceeded to ballot for its officers; the following brethren were elected:

Brother Jacob H. Brouner, Moderator; Garrat N. Bleecker, Clerk; William Winterton, Treasurer.

3. Ministering brethren present, belonging to sister associations, were invited to take seats with us, and assist in the deliberations of the body. The invitation was accepted by

- 4. Brethren William R. Williams, Wm. Arthur, Clapp, Mason, and Seely, were appointed a Committee to report on the state of religion within the bounds of the Association.
- 5. Brethren Sidney A. Corey, Davis and Tucker, were appointed a Committee to make arrangements for devotional exercises, and on overtures for religious benevolence.

Progress having been made in reading the letters, the Association adjourned to meet at 3 o'clock, P. M.

- 6. Brethren C. H. Underhill, Stokes and Morris, were appointed a Committee to examine the Minutes of Corresponding Associations.
- 7. Brother Arthur reported in behalf of the Committee appointed at last meeting of the Association to visit the church at Pittstown, "that they had attended to the duty assigned them, and that in answer to prayer, the divisions unhappily existing in that body, had been healed. They are now united and have a settled pastor."
- 8. Brethren E. Lathrop, R. Thompson, S. Wilkins, D. Williams, and Geo. Benedict were appointed a Committee to whom were referred all applications of churches for admission into this Association.

The Association assembled at 9 o'clock, pursuant to adjournment. Prayer by brother Thompson.

The Minutes of yesterday were read and approved.

10. A communication was received from the Sixth-st. Church, communicating the following extract from their church minutes:

Whereas, in the Providence of Almighty God, this church has been harrassed with difficulties for several years, arising from a suit in chancery, brought by one Johnson Chase, making it evident that it could not sustain its visibility in the worship of God by supporting the stated preaching of the Gospel; and have in accordance with such indications of Providence, been dismissing its members to other churches, with a view that as soon as circumstances should justify, it would dissolve itself as an independent Baptist church of Christ;

And whereas, the time having now arrived when we ought so to dissolve

as a church; be it therefore

Resolved, That we do now dissolve ourselves as a Church of Christ; believing that in so doing we are in the path of duty, and shall have the approbation of the Great Head of the Church, and that by uniting as individuals with other churches, we can be more useful in advancing the Redeemer's kingdom in the world.

- 11. Brethren J. L. Hodge, H. Davis, E. E. L. Taylor, W. W. Everts, and A. Haynes, were appointed a Committee to report the necessary arrangements for the next anniversary.
- 12. Brother Wm. R. Williams having resigned as a member and chairman of the Committee on the State of Religion within the bounds of the Association, brother Wm. Arthur was chosen chairman of the committee, and brother Isaac Orchard was appointed to fill the vacancy.
- 13. Brother Everts offered the following preamble and resolutions, which were seconded by brother Wm. Colgate, and, on motion, laid on the table until 4 o'clock this afternoon.

Whereas, By the unprecedented commercial activity of the population of this country, and especially of the large cities; by the universal and intense political excitements attendant upon the progress of a free government; by new and ever varying modes of social and moral organization, tending to divert from christian institutions the time, the sympathy, and the pecuniary support of the people; and by the influx of a foreign population, without churches, religious teachers, or adequate means for their evan-

gelization; the progress of religion greatly hindered among us, and the permanency and even the existence of its institutions menaced; therefore

Resolved, 1. That a portion of each session of this Association should be devoted, according to the provisions of the 11th article of the constitution, to serious and prayerful conference and inquiry as to the best modes of bringing the means of grace to bear in their pliancy and adaptation, upon every class and condition of the community.

2. That the employment of domestic missionaries to travel and preach among the destitute, keeping the churches advised of opening fields of usefulness, and acting as pioneers in rearing new interests; would greatly facilitate the duty of the Association, in the establishment of religion throughout its borders.

3. That whereas, places of worship must be multiplied in large and growing communities in proportion to the increase of population, and in their erection there is generally a reliance upon foreign assistance to a greater or less extent; and whereas that assistance should be rendered by neighboring churches, and should seldom be sought beyond the bounds of an Association;

Therefore, Resolved, That a Committee be appointed to report at the next session of the Association, upon the best mode of providing places of worship for destitute communities, and especially for the growing population of our large cities.

14. Brother E. Lathrop reported in behalf of the Committee on Letters from Churches making application for admission into the Association—that "applications had been received from the "Hope Chapel" Baptist Church in the city of New-York, and from the Green Point Baptist Church, Long Island."

After the above mentioned letters were read, and other desirable information obtained, it was

Resolved, 'That we recommend that the letters from the above churches be read before the Association, and that they be received as members of this body.

15. In accordance with the recommendation of the Committee, the letters from the two churches named in the report were read and on motion it was unanimously

Resol ed, That they be admitted as members of this Association,—

Whereupon, the Moderator, in behalf of the Association, gave the right hand of fellowship to the representatives severally of the following churches, viz: Brother David Bellamy, Pastor of the Hope Chapel, and brother A. Gamble, pastor of the Greenport Church, Long Island.

PLAN OF MINISTERS' WIDOWS' FUND.

Unanimously adopted August 3, 1826, and amended June 17, 1935.

In pious and grateful remembrance of our departed brethren in the ministry, whose widows and orphans may be left in circumstances of need, the Hudson River Baptist Association Resolved, to contribute to their relief, as far as our compassionate Saviour may indulge us with ability. In order. therefore, to create a Fund for this benevolent purpose, we recommend,

MEANS.

1. That on the fourth Lord's Day in May, in every year, the respective churches composing this Association, make a public collection, for the purpose of aiding this fund-

2. That a subscription book be opened in every such church and congregation to receive, whether annual subscriptions, or donations, to this desirable object.

OBJECTS.

1. Persons intended to receive the benefit of this fund, are the widows and orphans of deceased ministers, who at the time of their death, whether ordained or licensed, shall have been in good standing in this Association; and no others.

As to all the portions of said fund, received or accruing at or after the session of 1835, the Trustees of the fund have power, when the case of the applicant seems to be a peculiar one, to extend the advantages of the fund to the family of any deceased minister in good standing, who may at any time have belonged to this Association.

2. Relief afforded to widows to continue during their widowhood, and no longer.

3. If there be no surviving widow, and the children, if any, of such deceased minister be under twelve years of age, and in need, they shall receive the same portion as allowed to a widow, until they arrive at their fifteenth year. Provided also, that should any one of the said children, destitute of both father and mother, be found, by disease or accident, incapable of providing a living for him or herself, the allowance from this fund may continue until such person shall have arrived at twenty years of age.

MANAGERS OF THE FUND.

1. That this Association, at their annual meeting, shall elect and appoint out of its members five Trustees, who shall have the sole management of this fund; one of whom shall be appointed Treasurer, and one other as Secretary; and that such trustees continue in office three years; and until others are appointed.

2. That this Board of Trustees, (three of whom shall form a quorum,) shall meet annually, or oftener as the case may require, for the transaction of business; and that the said Board shall have the power to fill up any vacancy in their number which may be occasioned by death, or otherwise, until the next meeting of the Association.

3. All applications for relief shall be made to the Board in writing, stating the name, residence, and circumstances of the applicant.

4. It shall be the business of this Board to receive and keep in charge, all moneys collected, or otherwise contributed to this fund. To receive and examine all applications for relief, and that they make such allowance of money to the needy, as in their opinion, the case may require, and the state of the funds may warrant.

5. It is further Resolved, that this Board of Trustees, whenever the moneys in hand shall amount to \$300, and there be no applicant for immediate relief, be and they are hereby authorized to invest the same in some secure stock, or loan the same on bond and mortgage, for the purpose of creating a PERPETUAL FUND; the interest of which only shall be employed to relieve the necessitous. And further, whenever other moneys in their hands successively shall amount to \$100, and not be immediately required for use, the said sum shall be added to the perpetual fund; which it is presumed will ultimately prove essentially beneficial to the object intended. And likewise, that the said permanent fund shall in no wise be disposed of but by the order of three-fourths of this Association.

6. Finally, it is required that the Trustees of this Board present to this Association at their annual meeting, a statement of their funds, collections, and disbursements; with whatever else may be combined with this benevolent object, and the performance of their duty.

N. B. Whereas, it is highly probable that benevolent persons will be disposed to remember the *Ministers' Widows' Fund*, while making their last will and testament, the following form of a bequest is respectfully

submitted to their attention-

I give and bequeath to my executors herein named, the sum of

Dollars, in trust for the Ministers' Widows' Fund of the Hudson River Baptist Association, and direct my said executors to pay the same to the person who, at my decease, shall be acting as Treasurer of the said Fund, whose receipt shall be a sufficient discharge therefor.

22. Resolved, That agreeably to the request of the First Baptist Church of Putnam Valley, we hereby dismiss them to the Union Association, praying that their connexion may prove of mutual benefit.

(1.) Resolved, That our Treasurer be instructed to retain the funds contributed for this purpose in his own hands, and to pay them out only upon the order of the Missionary Committee, certified by their Secretary.

(2.) That the Missionary Committee be requested to hold regular quarterly meetings to receive applications, make appropriations, and give orders due for the previous quarter's service. The first of these meetings to be held immediately after the Association, the others on the last Mondays in the months of August, November and February, at 3 o'clock, P. M.

(3.) That the Committee be instructed to give orders for the amount due to the different missionaries, only upon condition that a satisfactory quarterly written report shall be presented to them of the labor performed.

In view of the enlarged efforts of the American and Foreign Bible Society to circulate the Scriptures throughout continental Europe, particularly in France and Germany, and also considerably to extend the work of home distribution, therefore

Resolved, That the churches and their pastors connected with this Association, be requested to make special efforts during the coming year, in favor of this truly christian enterprise.

34. Brother Welch, Chairman of the Missionary Committee, being prevented by indisposition from attending with us, brother Clapp, Secretary of the Committee, presented the following Report, which was adopted and ordered to be printed with the Minutes.

The Missionary Committee would report: that during the year they have endeavored to effect the purpose of their appointment, by investigating and responding to the urgent appeals from feeble churches within the bounds of the Association. The fund at the disposal of the Committee was small, and it has been distributed in a manner judged to be the most satisfactory to the body that imposed upon the Committee its responsibilities.

At the last meeting of the Association, it was requested that representatives should be sent from the churches applying for aid, together with their letters, to the meetings of the Committee. From their statements together with inquiries, a more accurate knowledge was obtained of their real necessities. We feel constrained to say, they were great,—far too extensive to be met with any prospect of success from the limited means of the Com-

mittee. Far too extensive when the aggregate amount expended within the last few years is taken into consideration.

One fact was made evident by the statements of these representatives,—that within the bounds of some churches who have long applied for aid, and usually received it, are brethren who are able to double, and in some cases to triple, their support for a preached gospel; and yet they compel the respective churches to which they belong to seek an appropriation from the funds of your Committee;—compel them by withholding, through a worldly spirit, what God in the blessing of prosperity has fairly made known as their duty to bestow.

The business character of the Committee in its connexion with the State Convention, has been a subject for our serious consideration, as we met from time to time. The mode of operation is marked with so many deficiencies that embarrassments seem necessary. It is not necessary, however, to mention particulars; but in view of the difficulties attending this connexion, and the consequent lack of efficient aid to the feeble churches within your bounds, it is recommended, either to direct the entire fund to the State Convention, or to the Home Mission Society, or otherwise to retain it at the disposal of your Committee.

Brethren, let some course be adopted, and that right early, to give greater efficiency to this department of your liberality. We trust that the Committee will not be disbanded. On the contrary our hope is that it will continue, but on a different basis: and more distinguished for its ability

by the increase of its funds and the economy of their distribution. Then will there be something above a mere pittance to extend to the feeble ones associated with you in this honored body,—and in due time their increased strength, and the abundance of their joy shall abound unto the riches of your liberality.

The minutes of the preceding meeting were read and approved.

41. The Committee appointed at the last meeting of this Association for the purpose "of corresponding with sister Associations upon the subject of preparing a history of the church of God, from its organization to the present time; tracing the progress and condition of the Saviour's kingdom through successive ages, and the best course to be adopted by the denomination for the attainment of this important object," not being prepared to report, it was

Resolved, That this matter be referred to Brethren Tucker, Ludlow, and Everts, who retired for consultation, and returned with the following report, which was unanimously adopted, the Association signifying their unanimous approbation by rising.

Whereas, This Association have received at its present session, no report from the committee appointed last year to correspond with sister Associations, upon the subject of preparing a history of the church from its organization to the present time, and believing the subject to be one of great importance—therefore,

Resolved unanimously, That this Association believing that Rev. Wm. R. Williams is eminently qualified to execute this work, do carnestly request him with as little delay as possible to enter upon its prosecution.

And whereas, Such a work in procuring the necessary documents and carrying on an extensive correspondence, will necessarily involve great personal labor and pecuniary outlay, therefore,

Resolved. That a committee of five be appointed to present the above resolution to Rev. Wim. R. Williams, and to co-operate with him in carrying out their design, and provide the necessary means.

- 42. On motion, Brethren E. Tucker, W. W. Everts, William Colgate, John R. Ludlow, and Friend Humphrey were appointed said Committee.
- 43. On motion of Brother Mason, the following preamble and resolutions were unanimously adopted.

Resolved, That the continual developement of circumstances

and events in our country, especially in the Western states, affecting the social and moral condition of community and the spiritual interests of Zion, show the necessity of establishing the institutions of the gospel freely, at all important points.

Resolved, That the experience, diligence, and wisely arranged appliances of the Home Mission Society for obtaining information and prosecuting their appropriate work of promoting the preaching of the gospel in North America, furnish ample grounds of confidence to its patrons, that their contributions to its treasury will be profitably and efficiently employed.

Resolved, That we recommend to the churches of this Association, such a liberal co-operation with the Home Mission Society, as will meet as far as practicable, the rapidly increasing wants of the country, particularly the feeble churches and needy ministers in the new states of the great west.

44. Whereus, It is a divine requisition that we be instant in season and out of season, and to do good as we have opportunity; and whereas, approbation and encouragement greatly strengthen the hands of those engaged in promoting the spiritual well-being of their fellows, therefore,

Resolved, That this Association cordially approbates, and looks with pleasure upon the efforts of any brother or company of brethren belonging to the churches composing this body, who by the employment of Colporteurs or otherwise, shall endeavor to promote the spiritual well-being of the foreign population pouring in upon us in such overwhelming numbers.

- 45. Resolved, That the surplus money received at the last meeting of this Association for printing minutes, amounting to \$59 32, be paid into the Widows' Fund.
- 46. Resolved, That in order to allow to the Committee on the State of Religion, the leisure requisite for the due preparation of their report, and to insure its earliest presentation, we henceforward add to our Rules of Order the following as

RULE XIV. Immediately after the Association has met, the Moderator of the last session, or in his absence the Chairman who presides at the organization of the Association, shall forthwith, after taking the chair, appoint a Committee to report upon the state of religion, and the members of such Committee whilst engaged in preparing their report, shall be excused from their attendance upon the Association.

46. Brother Arthur from the Committee on the State of Religion, made the following Report which was accepted, and directed to be printed with the minutes.

REPORT ON THE STATE OF RELIGION.

The letters of the churches present, with remarkable uniformity, one prominent and deeply interesting fact relative to the tone of feeling and the course of action prevalent during the past year. Instead of the voice of complaint, the letters this year bespeak gratitude to God for his fostering care in preserving to the churches his stated means of grace, and keeping them in the unity of the Spirit and bonds of peace.

There is a manifest return of confidence felt in the divinely appointed means, and a cheerful abiding trust that in their faithful and untiring use, the church will in due time see the salvation of God.

This, in the view of your Committee, betokens good, and we seem to see arising from it the little cloud which, though no larger than a man's handwill in due time span the heavens; and though as yet, but a drop has here and there fallen, we seem to hear in the distance the sound of abundance of rain.

- 1. First Church, Poughkeepsie—Are walking in the unity of the Spirit and bonds of peace. During the past winter and spring the Lord revived his work. Backsliders were reclaimed and sinners converted. While every thing indicated an extensive work of grace among them, it pleased God to lay upon a sick bed their beloved pastor. In him they continue to be strongly united. On account of feeble health, have consented to relinquish his labors till September next. Acknowledge the good hand of the Lord, in enabling them promptly to meet their pressing liabilities in the purchase of their meeting house. Have paid upwards of \$3,500 for that object. Sabbath school never more flourishing. Regard it emphatically the nursery of the church. Rev. Charles Van Loon, pastor.
- 2. Oliver-street.—This old and efficient body, in reviewing the dealings of the Lord towards them the last year, are led to exclaim, "Oh, that we were as in months past, when the candle of the Lord shined upon us!" still have not been without tokens of Divine favor. The Holy Spirit has accompanied the word preached to the hearts of saints and sinners. The spirit of union and brotherly love continues uninterruptedly to prevail-Feel a lively sympathy in all the various benevolent efforts of the day, and have been enabled to contribute their usual amount for their support. - 3. Hudson.—Nothing has occurred to interrupt the peace and unity of this Zion. They look back upon the past year as one of prosperity and encouragement. Rev. Leroy Church, pastor.
- 4. First Church, Troy This church express their gratitude to God for enabling them to complete and dedicate to His service their meeting house, on the site where their fathers worshipped for more than half a century. Enjoy peace—congregations large and attentive. Under the smiles of a

kind Providence, some mercy-drops have descended, and sinners have been brought into the fold of the great Shepherd. Deeply interested in all the benevolent operations of Zion. Rev. George C. Baldwin, pastor.

5. First Church, Albany .- Feel that they are unprofitable servants, and mourn that the Lord has passed them by. Are, however, enjoying peace among themselves, are happily united in their pastor, and hope that, under his arduous labors, the showers of Divine grace may soon descend. Rev. Wm. S. Clapp, pastor.

The pastor has been called by Divine providence to wade through the waters of deep affliction. It is small, but its prospects are good; the neighborhood is one that in a few years may be expected to have a large population. It is the first church that has been formed there, and arrangements are being made for the early erection of a house of worship. Rev. A. Gamble, pastor.

59. Hope Chapel, New-York.—This church has been constituted under very favorable circumstances, and was received into the Association at its present session. It is not only well disposed towards benevolent efforts in general, but it has one feature that is perhaps peculiar to itself. The congregation is associated under judicious regulations for affording mutual aid in seasons of affliction—thus precluding the necessity of any person connected with the church or congregation uniting with other societies. Rev. David Bellamy, pastor.

In conclusion, your Committee might, did their limited time allow it, suggest various reasons to explain why our churches do not enjoy a larger measure of prosperity, and also as to the appropriate remedies for spiritual declension.

They will content themselves with urging it upon the pastors and churches to make it a matter of earnest consideration, and devout self-examination, how far there may be found in ourselves, our conduct and spirit, our omissions or our practices, causes that avert the influences of the Holy Spirit, those influences that are first, last, and all, in the life and growth of the churches, in the power of the pulpit, and in the conversion of nations.

47. The following preamble and resolution was unanimously adopted.

Whereas, the increasing demands upon the treasury of the Widows' Fund, call for an increased liberality on the part of the churches, therefore,

Resolved, That this Association earnestly recommend to all the churches of this body, an annual collection on the Lord's day, preceding our anniversary, (or on some other more convenient day,) in aid of this most important object of their benevolence.

Resolved, That the collectors to this fund are hereby requested to see that the above resolution be carried into effect.

48. On motion, brother Sommers was requested to prepare an obituary notice of brother Samuel Ward, and that it be printed with the minutes.

In compliance with the above request, brother Sommers prepared the following obituary notice.

The decease of Rev. Samuel Ward, late pastor of the Baptist Church in Coxsackie, has called forth the sympathies and sorrows of many hearts. In no other region has the announcement of his early death fallen with greater weight, than within the bounds of the Hudson River Baptist Association, of which our lamented brother was a much loved member. This brief notice of our mutual bereavement, is prepared at the request of the

Association, as an expression of their sincers respect for the dead, and of condolence with the mourning widow, and of other members of our departed brother's family. May the Lord sustain and comfort them under this painful dispensation of his providence.

Brother Ward was hopefully converted to God at an early age; and baptized and received into the Baptist church in Calvert-street, Baltimore, under the pastoral care of Rev. Stephen P. Hill. Soon after his public profe-sion, it became apparent to the church, that this young disciple was endowed with gifts adapted to usefulness in the great work of the christian ministry. After prayerful and satisfactory examination of his moral and intellectual qualifications for the office, he was licensed to preach the gospel, and immediately commenced a course of literary and theological studies at the institution in Hamilton.

In 1542 he was ordained as the pastor of the Baptist Church in Galway in this state, from whence he removed and was installed as the pastor of the Baptist Church in Coxsackie, in 1845. His valuable ministerial labors in that place were of short duration; but long enough to endear him to the church, and indeed to the whole community in that village, where his active and devoted life terminated in a triumphant death, after about ten months of pulmonary sufferings.

In their annual letter to this body, the church in Coxsackie thus allude to the subject: "The past year has been one of peculiar trial to us. In July last our much esteemed and very excellent pastor was disabled by severe bleeding from the lungs, from the effects of which he never recovered, but continued to decline until the 8th April last, (1847) when at the age of twenty-nine years he departed this life, trusting in the merits of a risen Saviour. His, was a bright exemplification of the excellency and power of that religion which he faithfully preached while in health; and during his illness he seemed desirous of recovery, only that he might labor still more faithfully and effectually in winning souls to Christ." As death drew near, our beloved brother seemed in a remarkable manner to be " girding up the loins of his mind," and his hope, sustained by a living faith, grew strong in anticipating the grace that is to be revealed at the coming of the Lord. The precious promises of God were the rejoicing of his heart. And while enduring the greatest physical suffering, he was heard to exclaim, "O how glorious, how infinite, how unspeakable is the fulness of the promises of God." Some of his last moments were employed in exhorting those around him to give their hearts to God; and in praying that Christians in Coxsackie, and throughout the world, might be induced to arise and work for God "while the day lasts."

May that church and congregation—may all the ministers and churches of this Association, and all who witnessed the ardent piety of his life, be enabled to enturate his meek example and share in the glories of that cross, which enabled him to triumph over death, through faith in the blood of the Lamb.

49. Resolved, That the labors and plans of the American Tract

Society receive our warm sympathy and entire confidence, and that we recognize gratefully their efficient aid to our Foreign Missions, and rejoice in their expansive and well-directed efforts by colporteurs, to supply the destitute and ignorant of our own country, and trust the blessing of the great Head of the church may still rest on this benored Society.

50. Brother Thomas M. Burt presented a report in behalf of the Committee appointed to audit the accounts of the church in Kinderhook, in relation to the receipts and disbursements on account of the meeting house. Report accepted and placed on file.

51. Agreeably to request, Brother Edmund Kelly, an ordained Baptist minister from the state of Tennessee, imploring pecuniary aid to redeem himself from slavery, addressed the Association; whereupon it was

Resolved, That we have heard with deep interest the statement of Brother Kelly, and affectionately recommend his case to the liberality of the churches, composing this Association, and of all the friends of liberty and humanity.

52. Resolved, That the Association tender their grateful thanks to the members and congregations of the respective churches in this city, and to the Twelfth street Baptist church in particular, for their kind hospitalities so freely tendered, and so pleasantly enjoyed by this body during its present session.

The Minutes having been read and approved, the Moderator addressed the Association affectionately, thanking the great Head of the church for the harmony and brotherly kindness so conspicuous throughout the session; reminding every member of his obligation to labor and suffer for Him who died for us. Brother Tucker engaged in prayer. After pronouncing the benediction, the Association adjourned, to meet with the First Baptist church, Williamsburgh, at 10 o'clock, A. M., June 20, 1948.

STANDING RESOLUTIONS.

1. That the religious education of the young is a duty commending itself to every parental and christian feeling; that this Association hail with gratitude the increasing interest manifested by christians generally in Sabbath school instruction, and the tokens of enlarged success with which God is prospering that institution:—That they commend to all the churches of this body, the establishment and increase of these schools, to be furnished with good libraries, and to receive regular visits from the pastor.

6. Resolved, That the churches be requested to observe the last Thursday in February in each year, as the season of prayer for revivals in the various colleges and literary institutions in our country.

7. Resolved, That any member of this Association, who may attend Associations with which we correspond, shall be considered our delegate, provided he presents a copy of our minutes.
